Declaration of Compliance – H-SAA

Whereas the Finance, Audit and Risk Committee reviewed Sinai Health's Declaration of Compliance for the Hospital Service Accountability Agreement ("H-SAA") for the period April 1, 2024 to March 31, 2025, and recommended approval of same by the Sinai Health Board of Directors;

Declaration of Compliance – M-SAA

Whereas the Resources, Audit and Risk Committee reviewed Sinai Health's Declaration of Compliance for Multi-Sector Service Accountability Agreement ("M-SAA") for the period April 1, 2024 to March 31, 2025, and recommended approval of same by the Sinai Health Board of Directors;

Financial Results and Volume Performance YTD

Whereas the Finance, Audit and Risk Committee reviewed and endorsed the Financial Results and Volume Performance for the year-to-date period ended March 31, 2025 and recommended approval by the Boards of Directors of Sinai Health and Hennick Bridgepoint Health;

Be it resolved that the Boards of Directors of Sinai Health and Hennick Bridgepoint Health approve the Financial Results and Volume Performance, as presented.

Appointment of External Auditors/Public Accountants for 2025/26

Whereas the Finance, Audit and Risk Committee recommended that the Boards of Directors of Sinai Health System and Hennick Bridgepoint Health seek reappointment of PwC LLP as external auditors/public accountants for the Corporations for the year ending March 31, 2026 at the Annual General Meeting of the Members, at a fee to be determined in due course by the Boards of Directors;

Be it resolved that the Boards of Directors of Sinai Health System and Hennick Bridgepoint Health accept the recommendation of the Audit and Risk Management Committee, and recommend approval of same by the Members of the respective Corporations.

Financial Commitments Requiring Board Approval

Whereas the Finance, Audit and Risk Committee has reviewed and endorsed a request for the non-competitive procurement of Olink consumables with an estimated contract value of \$4 million dollars over three years (the "Commitment");

And whereas Management has completed the requisite diligence to ensure the appropriateness and suitability of the Commitment;

And whereas the Finance, Audit and Risk Committee recommends that the Sinai Health Board of Directors approve the Commitment, as presented;

Be it resolved that the Sinai Health Board of Directors approves entering into the Commitment.

3.0 GOVERNANCE

3.1 New Director Nominees

Andrew presented for discussion the proposed new Director nominees – Erez Eizenman, Barbara Hennick, Rob Kumer and Doug Nathanson. The biographies of the new Director nominees were circulated in advance.

4.0 RESOURCES AND PLANNING (RAP)

4.1 RAP Committee Update

Joanna Rotenberg, Chair of the RAP Committee, provided an update on the Real Estate Subcommittee. Joanna shared that EllisDon is no longer onsite at 600 University Ave. and all work is scheduled to be completed by the end of the month. Alternative options to 700 University are being explored for Mount Sinai Fertility. Discussions about capital planning continue to progress and the Committee is working on long-term capital uses. The EPR renewal process has had a number of challenges. Ontario Health continues to be involved and the Committee is currently exploring a potential shared instance and a standalone option.

5.0 FINANCE, AUDIT AND RISK (FAR)

Mark Wiseman, Chair of the FAR Committee, shared that the Committee last met on May 29 and endorsed all the year-end attestations – the compliance with service accountability agreements and the broader public sector requirement. The Committee also addressed the completion of the internal audit and scope of work for the next fiscal year. A table top exercise on disaster emergency management was held on May 22. The formal report from Deloitte with recommendations will be discussed at the next Committee meeting. Sinai Health finished the year with a small surplus while also achieving strong performance targets against the volume expectations.

5.1 Financial and Performance Results YTD March 2025

Rob Bull, EVP Finance, Facilities and Capital Development and CFO, provided an overview of Sinai Health's financial performance. Rob shared that the provincial budget headlines state there will be up to a 4% increase in funding for hospitals. However, specific numbers are not known yet and generally are provided at the end of June/early July. Typically, the actual result of base funding increase is closer to 2%, which is challenging given wage increases. The Ministry is launching a hospital sustainability program.

Rob also provided an overview of Sinai Health's volume performance. While volumes have grown since COVID-19, the Emergency Department has not yet reached pre-COVID volumes. The Sinai Health-to-Home program is expected to improve patient flow.

5.2 Approval of Audited Financial Statements

Mark shared that the Committee met with the auditors, PwC. The audit went well and an unqualified opinion is being issued.

Whereas the Finance, Audit and Risk Committee has reviewed the draft audited financial statements for Sinai Health System (SHS) and Hennick Bridgepoint Health (HBH) for the fiscal year ended March 31, 2025 (the "Financial Statements"), as prepared by management, and audited by PwC LLP, and reviewed the PwC 2025 Year-End Report;

And whereas PwC LLP, the auditors appointed by the members to conduct the financial statement audit, propose to issue standard opinions that the statements fairly present, in all material aspects, the statement of financial position, statement of operations and changes in net deficit, statement of remeasurement gains/losses (revenue and expenses for Hennick Bridgepoint Health), and statement of cash flows of each corporation;

And whereas, the Finance, Audit and Risk Committee recommends approval of the Financial Statements by the Boards of Directors;

Be it resolved that the Boards of Directors of SHS and HBH approve the Financial Statements for the fiscal year ended March 31, 2025.

6.0 HUMAN RESOURCES

6.1 Human Resources Committee Update

Ken Tanenbaum, Chair of the Human Resources Committee, provided an update noting the annual CEO performance assessment is in progress. The Committee approved the annual executive contingency plans and reviewed the HR metrics for the next fiscal year. The Committee has also been engaged with succession planning.

6.2 2024/25 Senior Executive at Risk Compensation Plan Performance and 2025/26 Senior Executive at Risk Compensation Plan Framework

Ken noted that the Committee approved the Compensation Plan Performance Report and Framework. The focus will continue to be on timely access to care and the EPR renewal.

2024/25 Senior Executive at Risk Compensation Plan Performance

Whereas the Human Resources Committee has reviewed the 2024/25 Senior Executive at Risk Compensation Plan Performance report, and recommended the Sinai Health Board of Directors approve the same;

Be it resolved that the Sinai Health Board of Directors approves the 2024/25 Senior Executive at Risk Compensation Plan Performance report, as presented.

2025/26 Senior Executive at Risk Compensation Plan Framework

Whereas the Human Resources Committee has reviewed the 2025/26 Senior Executive at Risk Compensation Plan Framework, and recommended the Sinai Health Board of Directors approve the same;

Be it resolved that the Sinai Health Board of Directors approves the 2025/26 Senior Executive at Risk Compensation Plan Framework, as presented.
